1. Does the entity expect that it will continue to have the current level of net operating cash flows for the time being and, if not, why not?

Answer:

*Yes, however the cash outflow for capitalised exploration and evaluation includes historic amounts that were settled by agreement with the final instalment of €60k being paid in this quarter.*

*Field and technical costs have been reduced to minimum levels whilst there have been travel and operating restrictions due to ongoing COVID-19. Costs incurred in the quarter were not material, however the Company continues to pay down cumulative outstanding creditors from prior periods.*

*The CEO and non-executive directors have continued deferred payment of salaries and fees until additional capital can be raised and the Selva project is granted development approval.*

2. Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?

Answer:

*The Company has ongoing support of the Board and major shareholders who have provided funding through unsecured loans, this facility has been further extended during the quarter and subsequently to provide interim funding whilst the Company completes plans for a more significant fund raising as plans progress with granting of development approval for the Selva project which is expected in Q1 2021.*

3. Does the entity expect to be able to continue its operations and to meet its business objectives and, if so, on what basis?

Answer:

*Yes. With the ongoing support of the Board and major shareholders with unsecured loans, ongoing measures to ensure security of assets and conserve cash and the plan to raise further capital in the near future the Directors are of the opinion that the entity will be able to continue its operations and meet its business objectives.*
